  - a. Currently tied down; Latitude was not the original owner and is aware of the issue. Nia emailed the son of the developer and he was able to give Nia the artist's name; working on a solution.

  - a. Developers are supposed to pay into the tree cover fund for each tree removed

b. Off topic: YMCA has removed trees without filing proper permits; they have blocked parking and placed a banner also without permits; Nia will contact Manny to see what the tree replacement provisions are in the covenant with the Y

# XVII. NCAC report:

- a. Last month's meeting was canceled
- b. Staples site: Collier is not aware of changes to the application, but current plan does not adhere to Va. Sq. sector plan, GLUP, or zoning. Met with Long Range Planning Committee to discuss the project; most agree that the project should not advance. There will be a 3<sup>rd</sup> LRPC meeting to be scheduled, date TBD. Received a request directly from the developer to meet privately with BVSCA and Ashton Heights to discuss other options. BVSCA's opposition is due to design (too close to adjacent townhome) and intensity of use; we are in favor of responsible development

#### XVIII. CivFed

- a. Moving Arlington to 100% renewable energy by 2035
- XIX. Cara Troup motioned and & Nate Troup seconded request to write a letter for an expanded walk zone at Science Focus and point out the fact that this is an anomaly among other Arlington County schools; motion passed
- XX. Future meetings: nominations will occur in April for June officer elections; no meeting in May

# Monique O'Grady presentation:

- a. Working on FY19 school budget; currently facing a multi-million dollar deficit and looking at cuts for staff, increasing class size, considering inclusion of students with learning differences into regular classrooms rather than pulling them out
- b. County board asked school board to come to them with a balanced budget
- c. School board will offer their budget in April and will solicit community feedback thereafter; presentation on April 19<sup>th</sup>, adoption on May 3<sup>rd</sup>
- d. Strategic plan: optimal learning environments, attracting & retaining staff, eliminating achievement gap, etc.—awaiting updates. If interested, please get involved; there will be opportunities to respond on the Engage website <a href="https://www.apsva.us/engage/">https://www.apsva.us/engage/</a>
- e. Elementary school boundaries: as we grow our school system (~+800 students per year; currently 29K students), the staff has asked School Board to consider taking some current neighborhood schools and switching their locations with option schools to minimize transportation concerns and making it easier to walk (need to hire more bus drivers)

- f. 4/12- staff will share draft recommendations, 4/16-4/23 will host open office hours to talk about recommendations; community meeting on 5/1, school board info presented on 5/17, School Board action on 6/21
- g. Elementary school boundaries process will occur in the fall; Feb. 2019 will be kindergarten registration and new boundaries will be implemented in Fall 2019
- h. Currently working on CIP 10 year spending plan. Current CIP funds have been spent on adding on to McKinley & Abingdon, creating new elem. school next to TJ (to be named Fleet School), adding new seats at career center, new HS at Wilson, etc.
  - i. School board to adopt new CIP in June, with opportunities for community to weigh in before adoption
- i. New elementary school at Reed in Westover; adding 1300 new HS seats with a bond (some to Ed Center, some to Career Center)
- j. Arlington Schools supported the 3/14 walk-out; have asked superintendent to examine current safety measures
- k. Registration for new students currently under way and need to be filed by April 16<sup>th</sup>
- I. School Board meetings will be moved to Syphax Center effective May
- m. School.board@apsva.us
- n. Questions and feedback:
  - i. One resident voiced concern about not being able to send her kids to Science Focus school despite being in the "walk zone" and several neighbors echoed her point (also emphasized traffic incidents, traffic flow with buses, shortage of bus drivers, etc.) Monique will be sharing this feedback with the board
  - ii. One resident asked about which school staff are slated to be cut and whether the changes will be drastic; Monique said they are considering their options
  - iii. Nia asked about whether there is a system in place for troubled children (as it relates to school safety); Monique said they are dedicating more money for psychologists and social workers in our schools over the next 3 years but budget restrictions may have to limit the addition of these staff. She noted that there are counselors in all of the schools.
  - iv. Monique noted that the best way to share interest is to write to the school board and get involved in the walk zone process
